## **1. Changes to The Broker's Workstation to prepare for "Automobile Statistical Plan" and "Usage-Based Automobile Insurance Pricing" in Ontario**

Recent changes introduced by GISA (General Insurance Statistical Agency) will come into effect January 1, 2014. The changes include new data elements and discount indicators, Vehicle Rate Group reporting requirements, Commercial Vehicle Type of Use classes, and current coding requirements. A usage-based auto insurance pricing model is being introduced by some carriers in Ontario. The Broker's Workstation has been enhanced to incorporate the changes.
