This is applicable for Cancellation Requests for auto policies (including private passenger vehicle, ATV, motor home, trailer, commercial vehicle, and commercial trailer) created on or after July 12.

When you are creating a Cancellation Request, **Insureds Request** can be selected in the **Reason** drop-down menu in the Cancellation Request form (see Figure 1.1).

- Make applicable selections in the **Canc. Code/Method** menus, as well. *Please note, although Short Rate is not available for selection in the Method drop-down menu, the cancellation will automatically be calculated by Short Rate, as applicable.*
